Schedule of Fees and Charges

Matter for Consideration:

Council to consider adopting the 2012/2013 Budget and also approve:-

- Differential and Minimum Rates
- Schedule of Fees and Charges

Background:

The budget has been prepared in accordance with Section 6.2 of the Local Government Act 1995. Council wished to maintain a differential rating base for the 2012/13 financial year and following the advertising process and the Ordinary Meeting of 20th July sought Ministerial approval as required. Ministerial approval has now been obtained.

Council has been working on preparation of the budget and the meeting of the Finance Committee on the 15th August carried out a full review of all the operating and capital income and expenditure schedules for recommendation to council; which was done at the Ordinary meeting held on 17th August 2012.

That the recommendation of the Finance committee that the schedules of income and expenditure on which the 2012/13 budget is based totalling \$8,868,350 and which is estimated will deliver a balanced budget be adopted and that to support the budget rates as under be adopted (subject to Ministerial Approval being obtained for the proposed 2012/13 differential rates)

Council at its' ordinary August meeting also reviewed the schedule of Fees and Charges and in accordance with Section 6.16 of the Local Government Act 1995, adopted the Schedule of Fees and Charges for inclusion in the Budget for the year ended 30 June 2013.

Now the full Budget document is available for adoption.

Statutory Environment:

Local Government Act 1995

Section 6.2-Requires a local government to prepare an annual budget by 31 August.

Section 6.32 – States that a local government in order to make up the budget deficiency is to impose a general rate on rateable land that may be imposed uniformly or differentially.

Section 6.33(1) – Provides that a local government cannot, without the approval of the Minister, impose a differential general rate that is more than twice the lowest differential general rate imposed.

Section 6.35 – States a local government before imposing any differential general rate provide at least 21 days public notice of its intention to do so.

Section 6.45 to 6.47 – Allows a local government to levy fees and interest, grant a discount for early payment and waive or grant concessions in relation to a rate or service charge.

Section 6.51 – Allows a local government to charge interest on a rate or service charge that remains unpaid after it is due and payable.

Section 6.16 – Allows a local government to impose and recover a fee or charge for any goods or services it provides or proposed to provide.

Financial Implications:

The budget outlines planned expenditure and revenue and determines the financial parameters for the Shire to operate within the 2012/2013 financial year. The proposed budget for the year is balanced with all the revenue to be received during the year and the estimated brought forward surplus being expended to meet operating expenditure demands, the capital works programmed and transfers to reserve for future years' expenditure.

Council did not adopt the Officer's Recommendation as following discussion it was felt that the rates needed to have a default penalty interest charge and instalment administration fee. These had not been charged in recent years but it was felt that they needed to be introduced to give people an incentive to pay their rates on time and to allow a recoup of costs for those that chose to pay by instalments.

The four instalment option is available with an instalment administration fee of \$15.00.

Interest on Instalments

Instalments which are not paid by the due date be charged penalty interest at the rate of 8% per annum calculated on a daily basis and the ratepayer's instalment option may be revoked.
